Heard Mr. Om Prakash, the learned counsel for the appellants and the learned A.P.P.

This appeal is directed against the order dated 25.02.2026 passed by the learned Sessions Judge, Pakur in B.P. No. 53 of 2026, arising out of Pakur (Muffasil) PS Case No. 29/2024, whereby and whereunder, the prayer for bail of the appellants has been rejected.

It has been alleged that several bombs and stones were thrown at the house of the informant.

Learned counsel for the appellants submits that none of the family members of the informant have suffered injuries. It has been submitted that several co-accused persons similarly situated have been granted bail in Cr. Appeal (DB) No. 460 of 2024 and Cr. Appeal (DB) No. 1389 of 2025. The learned counsel adds that the appellants are in custody since 13.02.2026.

Learned A.P.P. though has opposed the prayer for bail of the appellants but has not opposed the aforesaid submission.

Regard being had to the above, we while setting aside the order dated 25.02.2026 passed by the learned Sessions Judge, Pakur in B.P. No. 53 of 2026, arising out of Pakur (Muffasil) PS Case No. 29/2024 direct the

appellants be released on bail on furnishing bail bond of Rs. 10,000/- (Rs. Ten Thousand) each with two sureties of the like amount each to the satisfaction of learned S.D.J.M, Pakur in connection with Pakur (Muffasil) PS Case No. 29/2024.

This appeal is allowed.
