Learned counsel for the appellant submits that this interlocutory application has been filed with the prayer to confirm the provisional bail granted to the appellant vide order dated 11.03.2026 in connection with S.T. No. 04 of 2018 arising out of Gumla P.S. Case No. 232 of 2017 passed by the learned Additional Sessions Judge-I-cum-Special Judge, Gumla. It is next submitted that the appellant has been convicted vide impugned judgment of conviction dated 11.03.2026 and vide order of sentence dated 12.03.2026 has been sentenced as under:-

Offence u/s	Sentence	Fine	Default
376(1) of IPC	R.I. for 10 years	Rs.10,000/-	S.I. for six months

It is then submitted that after conviction, the appellant was given provisional bail for a period of 30 days on 11.03.2026. Learned counsel

for the appellant submits that the appellant has all along cooperated with the trial of the case. It is further submitted that the appellant has very good grounds to agitate in this appeal. It is also submitted that the appellant undertakes to cooperate with the hearing of this appeal. Hence, it is submitted that the provisional bail granted to the appellant be confirmed.

Considering the aforesaid facts of the case, the provisional bail granted to the appellant is confirmed till disposal of this appeal in connection with S.T. No. 04 of 2018 arising out of Gumla P.S. Case No. 232 of 2017 with the condition that the appellant will cooperate with the hearing of this appeal.

This interlocutory application is disposed of accordingly.
