From perusal of the writ petitions, it appears that the petitioner has given two different addresses i.e. *in W.P.(S) No.2379 of 2019*, he has mentioned his address as *Resident of Prem Nagar, P.O. – Sonardih, P.S. – Madhuban, District, Dhanbad, Jharkhand*; whereas *in W.P.(S) No. 1706 of 2018*, he has mentioned his address as *Resident of Village – Pradhan Khanta, P.O. – Pradhan Khanta, P.S. – Topchanchi, District – Dhanbad* and at present residing at *Prem Nagar, P.O. – Saraidih, P.S. – Madhuban, District – Dhanbad*.

Office is directed to issue Notice through the *Officer Incharge, P.S. – Madhuban, District, Dhanbad* as also through the *Officer Incharge of P.S. – Topchanchi, District – Dhanbad* to the petitioner to be physically present before this Court on the next date to explain as to why and under what circumstances two writ petitions have been filed by him for the same and similar relief, challenging the same impugned order i.e. Order No. 1346, dated 4/6.11.2017, passed by Project Officer, ABG Colliery. The Officer Incharge of both the Police Stations shall ensure physical appearance of the petitioner on the next date.

Put up both these cases on 24.10.2019.

Let a copy of this order be communicated to the Superintendent of Police, Dhanbad as well as to the Officer Incharge of the concerned Police Stations.
