I.A. No.2738 of 2022 & I.A. No.7915 of 2022:

I.A. No.2738 of 2022 has been filed on behalf of the petitioners for substitution of opposite party no.1- Suka Oraon, who has died during pendency of the present civil revision on 30th January, 2021.

Learned counsel for the petitioners submits that the opposite party no.1 died on 30th January, 2021 leaving his heirs and legal representatives i.e. his widow, namely, Sanicharyia Orain and two sons, namely, Eicho Oraon and Biju Oraon.

It has been stated in I.A. No.7915 of 2022 that Biju Oraon, son of Late Suka Oraon has also died on 12th August, 2022 leaving behind his heirs and successors i.e. his widow, namely, Poonam Orain @ Punam Devi and two minor sons, namely, Ajay Oraon, aged about 9 years; and Akchy Oraon, aged about 5 years; both represented through their natural guardian- mother i.e. Poonam Orain @ Punam Devi. It is, thus, submitted that the opposite party no.1 may, accordingly, be permitted to be substituted with the aforesaid heirs/ legal representatives, whose descriptions have been given in paragraph no.4 of both the interlocutory applications.

Having heard learned counsel for the petitioners and for the reasons stated in both the interlocutory applications, the opposite party no.1- Suka Oraon is permitted to be substituted with heirs/ legal representatives, whose descriptions have been given paragraph no.4 of both the interlocutory applications.

I.A. Nos.2738 and 7915 of 2022 are, accordingly, disposed of.

Learned counsel for the petitioners is directed to make necessary amendment in the cause title of the civil revision in course of the day.

I.A. No.3624 of 2022:

The present interlocutory application has been filed on behalf of the petitioners for substitution of the petitioner no.3- Mahrai Oraon @ Mahavir Oraon, who has died during pendency of the present civil revision on 25th November, 2020.

Learned counsel for the petitioners submits that certain inadvertent errors have been committed while drafting the present interlocutory application. Hence, he may be permitted to withdraw the same with a liberty to file a fresh one.

Considering the said submission, I.A. No.3624 of 2022 is dismissed as withdrawn with the aforesaid liberty.
