Heard the parties.

The petitioner has moved this Court for grant of bail in connection with Chainpur P.S. Case No.25 of 2026 registered for the offences punishable under sections 115(2), 118(1),117(2), 109, 126(2), 351 and 352 of the B.N.S., 2023.

The learned counsel for the petitioner submits that the allegation against the petitioner is that the petitioner attempted to murder of David Kurashi by assaulting him with a dagger. It is next submitted that the allegation against the petitioner is false. It is further submitted that for the same occurrence the petitioner has also lodged a case in connection with Chainpur P.S. Case No. 26 of 2026. It is then submitted that the petitioner has no intention to kill anybody. It is next submitted that the petitioner has been in custody since 27.01.2026, as has been mentioned in paragraph no. 12 of the bail application. It is then submitted that petitioner has no criminal antecedent as mentioned in para 11 and charge-sheet has been submitted against the petitioner. It is further submitted that the petitioner undertakes to cooperate with the trial of the case and further undertakes that he will not annoy or disturb the informant or the family members of the informant of the case in any manner during the trial of the case. Hence, it is submitted that the petitioner

be admitted to bail.

Considering the facts of this case, the above-named petitioner is directed to be enlarged on bail on furnishing bail bond of Rs.25,000/- (Rupees twenty five thousand) with two sureties of the like amount each to the satisfaction of learned Sub Divisional Judicial Magistrate, Palamau in connection with Chainpur P.S. Case No.25 of 2026 **with the condition that he will co-operate with the trial of the case and furnish his mobile number and photocopy of the Aadhar Card in the court below with an undertaking that he will not change his mobile number during the trial of the case and will not annoy or disturb the informant or witnesses of the case in any manner during the trial of the case.**
