Heard the parties.

The petitioner has been made accused in connection with
Katkamsandi P.S. Case No. 27 of 2026 registered for the offences
punishable under Sections 111(2), 111(4), 111(6), 317(2), 3(5) of the
B.N.S., 2023.

Learned counsel for the petitioner submits that the allegation
against the petitioner is that the petitioner indulged in committing
theft of Scorpio vehicle and they used to supply the stolen vehicle to
illegal liquor smuggler of Bihar. It is next submitted that the
allegation against the petitioner is false. It is then submitted that the
petitioner is the driver of the vehicle. It is further submitted that the
petitioner has been in custody since 12.02.2026 as is evident from
para-13 of the instant bail application. It is next submitted that the co-
accused, with similar allegations, has already been admitted to bail by
this Court vide order dated 28.04.2026 passed in B.A. No. 3523 of
2026. It is lastly submitted that the petitioner undertakes to co-operate
with the trial of the case and also undertakes not to annoy or disturb
the informant or the witnesses of the case in any manner during the
trial of the case. Hence, it is submitted that the petitioner be released
on bail.

Learned counsel appearing for the State opposes the prayer for

bail of the petitioner.

Considering the facts of this case, the above-named petitioner is directed to be enlarged on bail on furnishing bail bond of Rs.25,000/- (Rupees twenty five thousand) with two sureties of the like amount each to the satisfaction of the learned Judicial Magistrate-1st Class, Hazaribagh in connection with Katkamsandi P.S. Case No. 27 of 2026 **with the condition that he will co-operate with the trial of the case and furnish his mobile number and photocopy of the Aadhar Card in the court below with an undertaking that he will not change his mobile number during the trial of the case and he will not annoy or disturb the informant or the witnesses of the case in any manner during the trial of the case.**
