Heard the parties.

The petitioner has been made accused in connection Ichak P.S. Case No.130 of 2024 in NDPS Case No. 22 of 2026 registered for the offences punishable under Sections 18, 20, 22 of the Narcotic Drugs and Psychotropic Substances Act.

Learned counsel for the petitioner submits that the allegation against the petitioner is that from the possession of the co-accused Pintu Kumar Mehta, 13 gm of Brown Sugar and 620 gm of Ganja have been recovered and he disclosed the name of the petitioner as one of his associates. It is submitted that the allegation against the petitioner is false. It is next submitted that the petitioner has been implicated in this case only on the basis of confessional statement of the co-accused and nothing has been recovered from the possession of the petitioner. It is also submitted that the seized Narcotic Drugs and Psychotropic Substances do not come under commercial quantity. It is then submitted that the petitioner undertakes that he will co-operate with the trial of the case. It is lastly submitted that the petitioner has been in custody since 07.02.2026 as has been mentioned in para-13 of the instant bail application. Hence it is submitted that the petitioner be released on bail.

Learned Spl. P.P. opposes the prayer for bail.

Considering the facts of this case, the above-named petitioner is directed to be enlarged on bail on furnishing bail bond of Rs.25,000/- (Rupees twenty five thousand) with two sureties of the like amount each to the satisfaction of learned Sessions Judge-cum-Special Judge, N.D.P.S. Act, Hazaribagh in connection with Ichak P.S. Case No.130 of 2024 in NDPS Case No. 22 of 2026 with the condition that he will co-operate with the trial of the case and furnish his mobile number and photocopy of the Aadhar Card in the court below with an undertaking that he will not change his mobile number during the trial of the case and will not annoy or disturb the informant or witnesses of the case.
