1. Heard learned counsel for the parties.
2. This L.P.A is directed against order dated 06.02.2025 disposing of M.A. No. 280 of 2007.
3. In the case of **Alok Kumar Mallick Vs. Janardan Mahadani & Ors., L.P.A No. 208 of 2011**, decided on 16.03.2012, the Co-ordinate Bench has held that such an L.P.A. would not be maintainable given the provisions of Section 100-A of C.P.C.
4. Therefore, by following the reasoning in **Alok Kumar Mallick** (supra), we hold that this L.P.A is not maintainable and consequently, dismiss the same.
