1. Learned counsel for the petitioner is present. But none appears on behalf of the opposite party/husband, in spite of valid service of notice and sufficient opportunity given by this Court on earlier dates.
2. Heard learned counsel for the petitioner.
3. The present transfer petition has been filed under Section 24 of the Code of Civil Procedure for transfer of Original Suit No.754 of 2024, filed by the husband (opposite party) against the present petitioner (wife) from the Court of Principal Judge, Family Court, Ranchi to the Court of Principal Judge, Family Court, Daltonganj.
4. It has been submitted by learned counsel for the petitioner that the petitioner was married with the opposite party/husband in accordance with Hindu rites and customs on 12.03.2011. The petitioner has received notice of summon of the Original Suit No.754 of 2024 at that time when she was working in State Bank of India at Harmu in Ranchi. She appeared in the case but mediation process failed on 30.06.2025. Now, the petitioner has been transferred from the State Bank of India, Ranchi to the State Bank of India at Shahpur Branch in Daltonganj where she

is posted as Assistant Manager. It is further submitted that the petitioner's official duties, her responsibility to take care of her minor daughter and considering her health constraints due to past ailments, it is quite impracticable for the petitioner to attend the Family Court, Ranchi which is at a distance of about 150 k.m. away from Family Court, Daltonganj and to contest the suit at Ranchi, therefore, it is prayed that the said Original Suit No.754 of 2024 may be transferred from the Court of Principal Judge, Family Court, Ranchi to the Court of Principal Judge, Family Court, Daltonganj.

5. Considering the overall aspects of the case and the submissions on behalf of the petitioner, I feel inclined, in the ends of justice, to **allow** the prayer of the petitioner.
6. Accordingly, the proceedings of Original Suit No.754 of 2024 pending before the Court of Principal Judge, Family Court, Ranchi is hereby transferred to the Court of Principal Judge, Family Court, Daltonganj.
7. The present transfer petition stands disposed of.
