This criminal miscellaneous petition has been filed at the instance of the petitioners for restoration of Cr.M.P. No. 2886 of 2021 to its original file.

Though notice has validly been served upon the opposite party no.2 yet no one turns up on behalf of the opposite party no.2 in-spite of repeated calls.

Learned counsel for the petitioners submits that Cr.M.P. No. 2886 of 2021 was dismissed for non-prosecution. It is next submitted that as the counsel for the petitioners could not mark the case in the
