2. By filing this writ petition, the petitioner has made the following prayers:

"i. For issuance of an appropriate writ, writs /order, orders /direction, Directions upon the respondents to dispose the application dated 26.11.2025 which has been given before the respondent No 5 about Comply the order passed by the learned Additional Collector, Khunti in SAR Appeal No. 4R15/2012 order dated 28.09.2018, SAR Appeal No. 05R15/2012-13 04.12.2020, SAR 10/10-11 order dated 18.04.2012 and SAR Appeal No. 12R15/2012, order dated 30.09.2021, for restoration of possession of the land, at Mauja Khunti, Thana No. 83, Khata No. 46 Plot No. 1348, Total area about 2.77 Acres, in time frame fixed by the Hon'ble Court, and Despite repeated representations/ applications submitted before the respondent nos. 4 and 5, requesting for implementation of the said order, no effective action whatsoever has been taken till date, hence this writ petition is being filed.

ii. For issuance of an appropriate writ(s), order (s) or direction(s), upon the respondent No. 4 (Circle Officer,

Khunti), to produce the status report/action taken report with respect to the petitioner's application dated 26.11.2025.

And/or

To pass any such other order /orders, direction/directions as Your Lordship may deem fit and proper in the facts and circumstances of this case.”

- 3.** It is the prayer of the petitioner that his application dated 26.11.2025 which has been filed before the respondent no. 5-the Circle Officer, Khunti be disposed of at the earliest.
- 4.** Learned counsel for the respondents submits that if the application of the petitioner is pending, the same will be disposed of expeditiously.
- 5.** Considering the said submission, I direct the respondent no.5-Circle Officer, Khunti to dispose of the representation of the petitioner and take appropriate steps thereafter preferable within a period of eight weeks from the date of receipt of the copy of this order and communicate the same to the petitioner.
- 6.** Accordingly, this writ petition is **disposed of**.
