1. Mr. V. Shivnath, learned senior counsel appearing for respondent no.6 in L.P.A. No. 227 of 2012 & L.P.A. No. 231 of 2012 and respondent no.10 in L.P.A. No. 236 of 2012 is seeking time.

2. All other advocates have already canvassed their arguments, at length. Unnecessarily, the senior counsel has presumed that this Court will adjourn the matters on his request. Since long time these matters are continuing and have been argued out, at length.

3. We see no reason to adjourn these matters without any cost. Hence, these matters are adjourned with total cost of

Rs.2,50,000/- to be deposited by respondent no. 6 in L.P.A. nos. 227 & 231 of 2012 Rs.1,66,000/- and respondent no.10 in L.P.A. no.236 of 2012 Rs.84,000/- before the **Secretary, Women & Child Development and Social Security, Government of Jharkhand towards Juvenile Justice Fund and this amount will be used for the welfare of the juveniles. This amount shall be paid in Account no. 3734498462-5, Jharkhand Juvenile Justice Fund, State Bank of India, Project Bhawan, Hatia.**

4. Copy of this order will be sent to the Secretary, Department of Women & Child Development and Social Welfare, Government of Jharkhand and the Member Secretary, Jharkhand State Legal Services Authority, Nyay Sadan, Doranda, Ranchi.

5. These matters are adjourned on **25.04.2018**, subject to depositing the aforesaid amount by respondent no. 6 in L.P.A. nos. 227 & 231 of 2012 and respondent no.10 in L.P.A. no.236 of 2012.

6. If the aforesaid amount is not deposited before the next date, respondent no.6 in L.P.A. Nos. 227 & 231 of 2012 and respondent no.10 in L.P.A. Nos. 236 of 2012 shall remain physically present before this Court at 10:30 A.M. If the aforesaid amount is so deposited, there is no need of these respondents to remain physically present before this Court.
