Further, Registry is directed to delete the name and description of opposite party No.3 namely Biglahi Devi and to implead her only five legal representatives whose names, parentages and addresses have been mentioned in para-4 of the instant interlocutory application as opposite party No.3 (a) to 3 (e) with red ink in the cause title of this C.M.P.

This interlocutory application stands disposed of.
