The present C.M.P. has been filed on behalf of the petitioners seeking correction of the number of two plots of the land appertaining to Khata No. 220/672 situated at Mouza- Gumo as mentioned in the order dated 31.07.2025 passed in W.P.(C) No. 3481 of 2025.

2. Learned counsel for the petitioners while referring to different paragraphs of the present C.M.P. as well as the supplementary affidavit, submits that mistake was committed by the petitioners in mentioning the number of two plots in the writ petition, as a result of which similar error occurred in the order dated 31.07.2025 passed in W.P.(C) No. 3481 of 2025. The petitioners seek unconditional apology in committing the said factual mistake in the writ petition.

3. Learned counsel for the petitioners further submits that the error has occurred in the 8th line of the order dated 31.07.2025

passed in W.P.(C) No. 3481 of 2025 with respect to mentioning the number of two plots appertaining to Khata No. 220/672 as '5612/**6697**' and '**5727**/6685' instead of the correct numbers as '5612/**6679**' and '**5729**/6685'.

4. On perusal of the record, it appears that two opportunities were granted to the respondents to file counter affidavit on the said factual aspect.

5. Though a counter affidavit has been filed on behalf of the respondents, however nothing has been stated with respect to the error pointed out by the petitioners regarding the number of plots in question.

6. Under the said circumstance, the numbers of plots mentioned in the 8th line of the order dated 31.07.2025 passed in W.P.(C) No. 3481 of 2025 are corrected to be read as '5612/**6679**' and '**5729**/6685', subject to the condition that the petitioners pay a cost of Rs.2,000/- in favour of the Advocates' Clerks Association Welfare Fund, Jharkhand High Court, Ranchi within one week.

7. The order dated 31.07.2025 passed in W.P.(C) No. 3481 of 2025 is modified to the said extent.

8. The present C.M.P. is, accordingly, disposed of.

9. If the cost is not paid by the petitioners within the said period, the office shall point out the same and put up this case before the Bench.
