petition as it is the inter se dispute between the petitioners and the private respondents.

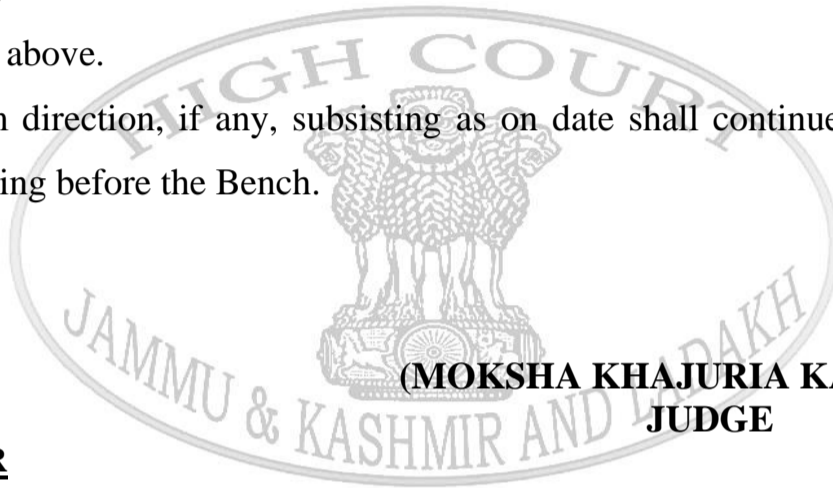
Ms. Heenah Baqal, learned counsel for the respondents 8 & 11 to 13 seeks and is granted four weeks' time for filing counter affidavit.
