1. Learned counsel for the petitioner seeks withdrawal of the bail application.
2. In view of this, the bail application is **dismissed as withdrawn**.

CRM(M) No. 294/2026

3. The petitioner has impugned the order dated 28.01.2026 passed by the court of learned Sessions Judge, Ramban (Designated Special Court under the SC/ST Prevention of Atrocities Act) in an application filed by respondent No. 2 for registration of FIR.
4. The petitioner has also sought quashing of FIR No. 0021/2026 dated 30.01.2026 registered with Police Station, Ramban under Section 3(1)(r) of the SC and ST (Prevention of Atrocities) Act, 1989 at the instance of respondent No. 2, who happens to be Sub-Inspector serving in the same Police Station. It is submitted that mere perusal of

the order impugned dated 28.01.2026 would reveal that the learned Sessions Judge, without waiting for the report from the concerned Police Station, has directed for registration of FIR.

5. Mr. Sunil Sethi, learned Senior counsel for the petitioner contends that the petitioner had not uploaded any comment, which can be termed as an offence under Section 3(1) (r) of the SC and ST (Prevention of Atrocities) Act. He has further drawn attention of this Court towards the report of SHO at Page No. 41 of the petition to urge that an official request was made to Meta for providing relevant information and response from the Meta was still awaited. Mr. Sethi further contends that the Face book Id, namely, Tigersingh Tigerstyle (Tiger 1) does not belong to the petitioner.
6. At this stage, notice be issued to respondent No. 1 only.
7. Mr. Eishaan Dadhichi, learned GA accepts notice.
8. Investigating Officer along with Case Diary shall remain present before the Court on the next date of hearing. Detailed status report be also filed by next date of hearing.
9. List on **01.04.2026**.
10. In the meanwhile, the charge sheet shall not be filed till next date of hearing only.
