ORDER
19.11.2024

On 07.04.2021, Division Bench of this Court passed the following
directions:-

“In view of the above, we direct the respondents to produce the cheque of Rs. 12,71,000/- in the name of the petitioners within a period of two weeks. The cheque shall be produced by Sh. Nanda, who is representing the Union Territory and if the amount is to be paid by the Union of India, the Union Territory may recover the same later on from the Union of India.”

In pursuance of the aforesaid directions, learned counsel for the respondent-Deputy Commissioner, Ramban has produced 10 cheques total amounting to Rs. 12,71,000/- particulars whereof are given as under:-
