ORDER
(12.08.2025)

- 01.** The petitioner, through the medium of the present writ petition, has sought a direction upon the respondents, particularly, respondent No. 5-Acharya Shri Chander College of Medical Sciences and Hospital, Sidhra, Jammu, to allow him to fill up his university examination form of 2nd Prof. of MBBS 2023 batch so as to enable him to appear in the 2nd Prof. examination of MBBS which is stated to have commenced from 04.08.2025.
- 02.** Learned counsel for the petitioner has submitted that similarly situated students had approached this Court by way of a writ petition bearing WP(C) No. 1444/2025 titled “**Saim Shabir & Ors. Vs. UOI & Ors.**” and had sought a

similar relief against the respondent No. 5. It has been submitted that an interim protection was granted to the said students in terms of an order dated 01.08.2025 passed in the said writ petition and on the grounds of parity, the petitioner is also seeking the similar relief.

- 03.** Issue notice to the respondents.
- 04.** Mr. Atharv Mahajan, learned counsel appearing vice Ms. Deepika Mahajan, learned counsel accepts notice on behalf of the respondent No. 2-National Medical Commission Under Graduate Medical Education Pocket 14 Sector, 8 Dwarka, New Delhi, Mr. Rajnish Raina, learned counsel accepts notice on behalf of the respondent No. 4-University of Jammu, Dr. B.R. Ambedkar Road, Jammu through its Vice Chancellor/Registrar and Mr. S. S. Ahmed, learned counsel accepts notice on behalf of the respondent No. 5-Acharya Shri Chander College of Medical Sciences and Hospital, Sidhra, Jammu. They seek time to file reply to the writ petition. Time is granted.
- 05.** Notice be sent to respondents No. 1 and 3 subject to taking of necessary steps by the petitioner within a week's time.

- 06.** List this petition along with WP(C) No. 1444/2025 on 08.09.2025.
- 07.** Meanwhile, it is directed that the respondent No. 4- University of Jammu, Dr. B.R. Ambedkar Road, Jammu through its Vice Chancellor/Registrar and respondent No. 5- Acharya Shri Chander College of Medical Sciences and Hospital, Sidhra, Jammu, shall allow the petitioner to take his 2nd Prof. examination provisionally at his own risk and cost, however, the result of the petitioner shall not be declared without the permission of this Court.
