- 01.** Writ petition WP(C) No. 2299/2022 filed by the petitioners came to be disposed of without adjudication on merits by the writ court in terms of an order dated 03.03.2025 by purported reference to identically filed writ petition getting disposed of.
- 02.** Accordingly, the writ court by, virtue of an order dated 03.03.2025, directed the writ respondents to consider the petitioners' claim for fixation and releasing of revised pay benefits and effects under Government Order No. 92 of 2009 and also arrears of 6th and 7th Pay Commission recommendations. Needful as directed was to be done within a period of two months from the date of a certified copy of the order dated 03.03.2025 was to be provided to the writ respondents by the petitioners.

- 04.** The counsel for the petitioners is referring that the copy of the order was sent along with legal notice which cannot be true statement of fact
- 05.** Be that as it may, issue notice to the respondents/contemnors.
- 06.** Mrs. Monika Kohli, learned Senior Additional Advocate General, accepts notice on behalf of the respondent No. 1 and Mr. Dewakar Sharma, learned Deputy Advocate General accepts notice on behalf of the respondents No. 2 to 4.
- 07.** List on 03.12.2025.
- 08.** Respective statement of facts be filed by next date of hearing.
- 09.** Copy of this contempt petition be provided against receipt to Mrs. Monika Kohli, learned Senior Additional Advocate General as well as also to Mr. Dewakar Sharma, learned Deputy Advocate General, by counsel for the petitioners.
