ORDER
(27.04.2026)

CrIM No. 655/2026 in CRM(M) No. 1148/2025

1. Through medium of CrIM No. **655/2026**, the petitioner intends to withdraw his petition CRM(M) No. **1148/2025** so as to maintain his bail application on record and pursue the same.
2. Application is, thus, **allowed**.
3. CRM(M) No. 1148/2025 is **dismissed** as withdrawn without prejudice to the right of the petitioner in seeking adjudication of the bail application on merits.

4. Today, PSI Mohd. Amjad Bali of the Police Station, Bishnah is present in person along with Case Diary file with respect to FIR No. **54/2025**.
5. The genesis of registration of FIR No. **54/2025** is relatable to the custody of the petitioner in FIR No. **53/2025** of the Police Station, Miran Sahib in relation to which the petitioner was being taken for

investigation purposes when he is said to have scuffled with the police party escorting him and in the process succeeded in snatching from Constable Arun Sharma his weapon and leaving him as well as one Constable Mangat Ram injured resulting in the registration of FIR No. **54/2025**.

6. This Court has perused the Case Diary file.

7. The very fact that registration of FIR No. **53/2025** is dated **09.06.2025** and the investigation is still far from being taken to its logical conclusion is reflective of the fact that the investigation is going on at a snail's pace for the reasons best known to the SHO Police Station Bishnah.

8. Under the constraints of circumstances of this case, this Court deems it appropriate to direct the Investigating Officer of FIR No. **53/2025** of the Police Station, Miran Sahib to come along with the Case Diary file on the next date of hearing.

9. List this case on **13.05.2026**.

10. A copy of this order be provided to Mr. Pawan Dev Singh, learned Dy. AG.

11. PSI Mohd. Amjad Bali of the Police Station, Bishnah along with Case Diary file is now relieved from his attendance.
