1. The complainant has filed the present complaint alleging
willful disobedience of the order dated 18.06.2024 passed by the
learned Single Judge in Writ Petition No.10515/2024 (LB-RES). In



terms of the said order, the court had directed the Panchayat Development Officer, Manchanehalli Gram Panchayat to break open compound walls wherever roads are provided in the layout which are blocking access to the neighbouring properties.

2. The accused have filed a compliance affidavit enclosing therewith photographs to show that the compound walls have been removed.

3. The complaint is, accordingly, closed.
