**ORAL ORDER ON I.A. NO.1/2026**

1. This is an application seeking recall of the order dated 26.02.2026, whereby in view of the fact that there was no appearance on behalf of the Administrator appointed for the Petitioner Company despite service, the matter was closed. Liberty was however granted by this Court to the Administrator to revive these proceedings.

2. It is apposite to set out the relevant extract of the order dated 26.02.2026 below:

*"3. Learned counsel for the petitioner has informed the Court that an Administrator was appointed for the petitioner. Subsequently, this Court had issued notice to the Administrator on 06.02.2026 as follows:*

*"1. Learned counsel for the petitioner has filed a memo stating that by order dated 17.01.2026 of Joint Registrar of Co-operative Society, Bangalore Division, Bangalore, Sri Hamid Ullah Khan, Co-operative Development Officer, III Zone, Bangalore Urban District, Bangalore has been appointed as the Administrator of the petitioner society.*

*2. Accordingly issue emergent court notice to the Administrator Sri. Hamid Ullah Khan, Co-operative Development Officer, III Zone, Bangalore Urban District, Bangalore returnable by 26.02.2026.*

*3. List the petition on 26.02.2026."*

*4. The report of the registry is that the notice stands served to the Administrator. However, none appears for the Administrator. Given what is stated above, this petition cannot proceed any further.*

*5. Accordingly, the petition is **disposed off**, granting liberty to the Administrator to revive it, if necessary, and in accordance with law. All pending applications stand closed."*

3. Learned Counsel appearing for the Administrator appointed for the Petitioner submits that he has filed an application with a Vakalatnama on 03.07.2026, on behalf of the Administrator to contest these proceedings.

4. The learned counsel for the Respondent on the other hand states that the person who has sworn to the Affidavit is not one of the two Administrators of the Petitioner Company.

5. Issue Notice. Let a Reply to I.A.No.1/2026, be filed by the Respondent within 3 weeks.
