4. In that light, I deem it appropriate to extend the interim order for a period of 4 weeks, to enable the petitioner to file an application before the concerned Court and the concerned Court to pass necessary orders for grant of bail or otherwise.

5. For the aforesaid reasons, the following:

ORDER

(i) Criminal Petition is disposed reserving liberty to the petitioner to approach this Court in the event a final report is filed and the final report would go against him.

(ii) The interim order if any subsisting as on today shall stand extended for a period of 4 weeks, only for the purpose of enabling the petitioner to apply for grant of anticipatory bail.

(iii) In the event the petitioner would not avail of the remedy of filing an application seeking anticipatory
