The present batch of petitions is instituted by the petitioners, who were members of the Special Task Force constituted for the specific purpose of apprehending the notorious forest brigand Koose Munisamy Veerappan. The

petitioners call in question the legality and correctness of the endorsement issued by respondent No.2, as produced at Annexure-B, and seek a consequential writ in the nature of mandamus directing the respondents to release the reward amount payable to them in terms of the Government Resolution and Order dated 08.07.2005.

2. Heard the learned counsel appearing for the petitioners and the learned Additional Government Advocate appearing for the respondent-State. The material placed on record has been carefully perused.

3. The short question that arises for consideration is as to whether the endorsement dated 17.08.2015, as produced at Annexure-B, is liable to be interfered with, particularly in the light of the judgment rendered by a Coordinate Bench of this Court in a batch of writ petitions, the lead matter being W.P.No.10982/2018, wherein the very same endorsement has been set aside and

appropriate directions have been issued in two connected judgments.

4. An ancillary, yet significant, issue that falls for consideration is as to whether the petitioners, who were serving in the Forest Department and were associated with the Special Task Force constituted exclusively for the purpose of tracking and neutralizing the said forest brigand, can be denied the benefit of the reward in terms of Government Order No. HD 33: PO 2005, Bengaluru.

5. This precise controversy is no longer res integra, inasmuch as a Coordinate Bench of this Court has already examined the issue in extenso and has proceeded to quash the very same endorsement impugned herein. In that view of the matter, it would be apposite to extract paragraph 10 as well as the operative portion of the order passed in W.P.No.10982/2018 c/w W.P.No.50155/2015, which reads as under:

"10. It is not in dispute that the petitioners were all part of the STF which was constituted by the State Government to nab the forest brigand Mr. Veerappan. It is a matter of record that several officers of the Department of Police and Department of Forest had laid down their lives at the hands of Mr. Veerappan while serving the STF. The DG and IGP in terms of his letter dated 24.01.2005 had sent a proposal to the State Government to reward the personnel from the Forest Department, Department of Police and the informants who were involved in events leading upto the day of hunting down the forest brigand. Following this, the respondent No.1 had issued a Government Order dated 08.07.2005 accepting the proposal as submitted by the DG and IGP of Police. Apart from this, an increment was ordered to be given to all those employees who were part of the STF and were granted the benefit of a site in a District Place. A list of persons who were entitled to the reward was prepared. The names of the petitioners were found in the said list of employees of the Department of Forest who were eligible for the reward. It appears that the request of the petitioners was not considered despite representations made by them which compelled them to file W.P.Nos.2765-2796/2015 before this Court which were disposed off in terms of the order

dated 27.01.2015. Since the representation of the petitioners were not considered by the respondent No.3, C.C.C.Nos.654-672/2015 were filed. After service of notice in the contempt petitions, the respondent No.1 held proceedings and restricted reward to only six persons who were part of the STF when Mr. Veerappan was gunned down on 18.10.2004. This apparently was on the ground that granting the reward to those employees who were part of the STF would result in enormous expenditure to the State Exchequer as the amount set apart for the reward was exhausted. Respondent Nos.1 and 2 being model employers were bound to stick to the promise made by the Executive Order dated 08.07.2005 offering the reward to the department staff who were part of STF, including the petitioners. A promise is made to be honoured and not to be broken and a promise made by a sovereign State has its own intrinsic value, giving a sense of purpose and pride to whom it is made. It is known the world over that Mr. Veerappan was not gunned down in a day, but it took several lives and several years and several persons had risked their lives in providing information about Mr. Veerappan from time to time. The State could have either rewarded all who were involved in hunting down of Mr. Veerappan or not at all. It could not have trivialized the effort and

courage of all those who were killed or who had survived the onslaught of the brigand, by restricting the reward to only a handful. The action on the part of the respondents in restricting the reward to few persons from the Forest Department is not sensible and shows the insensitivity of the State Government. Therefore, to grant the reward to only persons who were part of the STF on 18.10.2004 does not stand to reason but is indeed an act of discrimination. Therefore, the impugned order passed by the respondent No.2 deserves to be interfered with. Consequently, the following:

ORDER

- i. The Writ Petitions are allowed.*
- ii. The order Dated 17.08.2015 passed by the respondent No.2 - Additional Secretary, Department of Forest and Environment, bearing No.CYÀfÃ 113 CYÀ,ÉÃ 2007, Bangalore, in so far as it relates to the petitioner in W.P.No.10982/2018 and petitioners in W.P.No.50155/2015 is quashed.*
- iii. Respondent Nos.1 and 2 are directed to take immediate steps to release the reward payable to the petitioner in W.P.No.10982/2018 and petitioners in*

W.P.No.50155/2015 as per the Government Order dated 08.07.2005. This shall be done within a period of three months from the date of receipt of a certified copy of this order."

6. Having given anxious consideration to the findings recorded by the Coordinate Bench in the judgment extracted supra, this Court is of the considered view that the stand now canvassed by the State, seeking to deny the petitioners the benefit of reward, is wholly untenable and cannot be countenanced. The Coordinate Bench, upon an elaborate examination of the factual matrix, has categorically held that once the names of the personnel, including those from the Forest Department, are found in the list of eligible beneficiaries prepared pursuant to the Government Order dated 08.07.2005, the State is estopped from denying such benefit on a specious plea that only a limited set of officers, who were present on the date when Koose Munisamy Veerappan was neutralized on 18.10.2004, would alone be entitled for the

reward. The said contention of the State has been expressly rejected as being arbitrary, discriminatory, and contrary to the very object of the Government Order. This Court finds that the petitioners herein stand on identical footing as that of the petitioners in the earlier batch of writ petitions, and therefore, the denial of reward to the present petitioners would amount to perpetuation of an illegality which already stands corrected by judicial intervention.

7. This Court is also fortified in its view by the well-settled principle of law that when a Court has adjudicated upon an issue and granted relief in respect of a class of persons, the State and its instrumentalities, being model employers, are under a constitutional obligation to extend the benefit of such adjudication to all similarly situated persons, without driving each one of them to approach the Court individually. In this regard, though rendered in a different factual context, the principles enunciated by the Division Bench in ***Nagappa***

vs. State of Karnataka¹ are squarely applicable to the case on hand. The Division Bench has emphatically held that once a matter has attained finality and relief is granted, the authorities are duty-bound to uniformly apply the same to all eligible persons forming part of the same class. Applying the said principle to the present case, this Court is of the opinion that the respondents cannot discriminate between the petitioners herein and those who have already been extended the benefit pursuant to the earlier judgment.

8. In that view of the matter, this Court holds that the present petitions are liable to succeed. More so, the very endorsement dated 17.08.2015, as produced at Annexure-B, which forms the substratum of the dispute, has already been quashed by a Coordinate Bench of this Court. Therefore, the continuance of the said endorsement, insofar as it relates to the present petitioners, cannot be sustained in the eye of law. The

petitioners, whose names admittedly find place in the list of eligible personnel, are entitled to be considered for grant of reward in terms of the Government Order dated 08.07.2005, and the respondents are bound to act in consonance with the directions already issued by this Court in the earlier round of litigation.

9. For the foregoing reasons, this Court proceeds to pass the following:

ORDER

(i) The writ petitions are ***allowed***;

(ii) The endorsement dated 17.08.2015 issued by respondent No.2, as produced at Annexure-B, insofar as it relates to the present petitioners, stands quashed;

(iii) Respondent Nos.1 and 2 are directed to consider the case of the petitioners for release of the reward amount in terms of the Government Order dated 08.07.2005, keeping in view the law

laid down by this Court in W.P.No.10982/2018
c/w W.P.No.50155/2015;

(iv) Such consideration shall be undertaken expeditiously and in any event within a period of twelve weeks from the date of receipt of a certified copy of this order;

(v) It is made clear that the respondents shall extend the benefit to the petitioners on parity with other similarly placed personnel, without driving them to further rounds of litigation.
