ORAL ORDER

The petitioner in Crl.P.No.1562/2021 is filed by accused
Nos.2 and 3 in C.C. No.1526/2021 pending trial before VII
Additional Chief Metropolitan Magistrate, Bengaluru, for the
offences punishable under Section 498A read with Section 34 of
IPC.

2. Crl.P. No.15306/2025 is filed by accused No.1 in
C.C No.1526/2021 pending trial before VII Additional Chief
Judicial Magistrate, Bengaluru, for the offences punishable
under Section 498A read with Section 34 of IPC.



3. The petitioners in both the petitions have sought for quashing the charge sheet filed in C.C No.1526/2021.

4. When these petitions are listed for admission, it is brought to the notice of the Court that the parties have settled the dispute amicably and the same is reported in RPFC No.200041/2025 before the Kalaburagi bench of this Court.

5. A perusal of the order passed in RPFC No.200041/2025 shows that the parties have consented for quashing the proceedings initiated in C.C. No.1526/2021.

6. In that view of the matter, both the petitions are **allowed** and the prosecution launched against the petitioners by the respondent No.1 in C.C. No.1526/2021 pending trial before VII Additional Chief Judicial Magistrate, Bengaluru, for the offences punishable under Section 498A read with Section 34 of IPC is quashed.
