ORAL ORDER

(PER: HON'BLE MR. VIBHU BAKHRU, CHIEF JUSTICE)

1. The learned counsel for the complainants has joined through video conferencing.
2. The complainants have filed the present complaint alleging wilful disobedience of the order dated 24.04.2024 passed by the learned Single Judge of this Court in W.P.No.21117/2023 (LB-BMP). The operative part of the said order reads as under:

"The petition is allowed, and the third respondent's impugned Endorsement dated 07.10.2023 [Annexure-K] is quashed directing restoration of the revenue entries in favour of the petitioners' predecessor-in-interest [Sri.T.V.Ramakrishna Reddy] but directing the third respondent to issue fresh notice on the continuation of the revenue entries for the subject property. The third respondent shall initiate such proceedings at the earliest and in any event on or before 30.06.2024.

3. The learned counsel appearing for the accused has filed a memo of compliance stating that the order has been complied with and the katha has been restored in the name of the complainants' predecessor-in-interest (Sri. T.V.Ramakrishna Reddy). Photocopy of the katha is also enclosed with the said memo.
