which registers C.C. No.235/2024. The issue in the *lis* is  
not with regard to the merit of the matter therein, but the  
act of the respondent accused for filing the evidence by

have stayed the matter. Therefore, the concerned Court  
shall now endeavour to conclude the proceedings within an
