ORAL ORDER

The petitioners filed this writ petition seeking a mandamus directing respondent No.1 to decide the dispute/petition filed by the petitioners under Section 70(2)(c) of the Karnataka Co-operative Societies Act, 1959 ('Act' for short) in Dispute No.JRM/DDS/71/2025-26 so far as the petitioners are concerned vide Annexure-A.

2. It is the case of the petitioners that, the petitioners have raised a dispute under Section 70(2)(c) of the Act. The dispute is still pending consideration before respondent No.1. Hence, this petition.

3. Learned AGA for respondent No.1 submits that, if reasonable time is granted, respondent No.1 would dispose of the dispute raised by the petitioners.

4. In view of the submission made by learned AGA, this writ petition is ***disposed of*** directing respondent No.1 to dispose of the dispute under section 70(2)(c) of



the Act, raised by the petitioners within 3 months from the date of receipt of a certified copy of this order.

5. The parties to the petition are directed to co-operate with respondent No.1 for early disposal of the dispute.

6. In view of disposal of the petition, pending IA(s), if any, shall stand disposed of.
