**ORAL ORDER**

1. In this writ petition, the petitioner sought for the following relief/s:

*"i. Issue necessary direction directing the respondents to consider the representation dated: 29.09.2023 given by the petitioner as per Annexure-A.*

*ii. Issue necessary direction, directing the respondents to take back the petitioner back in his service.*

*iii. Grant such other relief or reliefs as this Hon'ble court deems fit in the facts and circumstances of the case in the interest of justice and equity."*

2. It is observed that the petitioner has an efficacious alternative remedy under the provisions of the Karnataka Education Act, 1983.

3. In view of the above, the writ petition is disposed of, reserving liberty to the petitioner to approach the
