ORAL ORDER

Heard. Mrs. Bhushani Kumar, learned counsel for the petitioner in W.P.No.7234/2025 who represents respondent in the connected matter. Also heard Sri.Tejas, who represents Ms.Dhanalakshmi Y., learned counsel on record for the respondent in W.P.No.7234/2025 who is representing the petitioner in the connected petition i.e., W.P.No.19376/2025.

2. While writ petition No.7234/2025 is filed by the wife, writ petition No.19376/2025 is filed by the husband.

3. Seeking the Court to quash the common order that is passed by the Court of Principal Judge, Family Court, Bengaluru on I.A. No.IV and I.A. No.VI in G & WC No.90/2022 dated 22.01.2025, both the writ petitions are filed.



4. On hearing both the learned counsel, the parties, Ms. Karuna P and Sri. Vijay S., who appears in person before this Court and basing on the consensus arrived at by both the parties, both the writ petitions are disposed of with the following:

ORDER

- i) The common order that is rendered by the Court of Principal Judge, Family Court, Bengaluru on I.A. No.IV and I.A. No.VI in G & WC No.90/2022 dated 22.01.2025 is modified.
- ii) Father is permitted to have the custody of Master Somasohan V. from 02.00 p.m. to 05.00 p.m. on every Sunday for a period of two months from the date of this order.
- iii) Father is permitted to have the custody of Master Somasohan V. from 02.00 p.m. to 06.00 p.m. thereafter till the disposal of G&WC No.90/2022 or until further orders, if any made by the Family Court due to change of circumstances.



- iv) Mother shall hand over the custody of Master Somasohan V. at M. N. Krishna Rao Park, Basavanagudi on every Sunday at 02.00 p.m. to the father.
- v) Father is permitted to spend time with Master Somasohan V. either at M. N. Krishna Rao Park, Basavanagudi or at the Kids Section of Forum Mall, Koramangala or at Kids Section of Mantri Mall, Malleswaram.
- vi) Father is not permitted to take Master Somasohan V. to any other place without consent of the mother.
- vii) During the time of visit by father, the paternal grand parents of Master Somasohan V. are permitted to join.
- viii) So far as second medical opinion or providing better treatment to Master Somasohan V. is concerned, in case father wants to do so, it can be done. However, Master Somasohan V. has to be taken either for medical opinion or for better medical treatment only when mother accompanies.



- ix) Father shall not take any photographs or videographs whatsoever during the time of visitation.
- x) The particulars of the treatment already provided and which will be provided hereafter shall be placed before the Family Court as soon as the same is done.
- xi) For the first two months, mother is permitted to be with Master Somasohan V. during the time of visitation. Thereafter, father is permitted to spend time with Master Somasohan V. alone.

Both the writ petitions are accordingly disposed of.
