Learned Additional Government Advocate takes notice for respondent Nos.1 to 4. Notice to the other respondents is not necessary for the following reasons.

Although the prayer in the writ petition is to issue a writ of mandamus directing the respondent authorities to consider the representation at Annexure-Q, learned Additional Government Advocate points out that the representation at Annexure-Q is given by 'Dr.B.R.Ambedkar Suvarna Karnataka Karmikara Vedike' and not by the petitioners. It is submitted that no specific information regarding the petitioners is forthcoming from the representations.

3. Upholding the submissions of the learned Additional Government Advocate, the writ petition stands ***disposed of***, reserving liberty to the petitioner to give representation to the competent authority to consider the grievances of the petitioners.

Ordered accordingly.
