1. The petitioner is before this Court seeking for the following reliefs:
 - a) *Issue a writ of mandamus directing the Respondent/Karur Vysya Bank Ltd to De-Freeze the current Account of the Petitioner bearing No.1333155000002195 having its branch at HSR Layout, Bangalore;*
 - b) *Pass such other direction or orders as this Hon'ble Court deems fit in the facts and circumstances of the case, in the interest of justice and equity.*
2. Learned counsel for respondent No.1, on instructions, submits that respondent No.1 has defreezed the account of the petitioner and there is no lien which has been marked on the account of the petitioner.
3. In that view of the matter nothing survives in the above petition. Petition is ***dismissed as infructuous.***
