In view of the fact that the aforesaid suit in O.S.No.1008/2012 is pending for the last fourteen years, without expressing any opinion on the merits / demerits of the rival contentions, I deem it just and appropriate to direct the Trial Court to dispose of the aforesaid suit as expeditiously as possible and preferably within a period of nine months from the date of receipt of a copy of this order.
