ORAL ORDER

The petitioner has challenged the notice dated 09.02.2023 issued by the respondent in this writ petition. It is contended that, the respondent-Bank has issued a certificate dated 12.09.2025 stating that, Loan Account No.07002/58 has been closed on 10.09.2025. The petitioner has produced a copy of the certificate.

2. Learned counsel for the petitioner submits that, pursuant to the order dated 11.04.2023, the petitioner has deposited an amount of Rs.1,00,000/- before this Court and prays to release the said amount in favour of the petitioner.

3. The submission is placed on record.

4. Registry is directed to release the said amount in favour of the petitioner after due identification.

5. The petitioner is also permitted to furnish his account details to the Registry.



6. As the petitioner has already repaid the entire outstanding dues and the respondent-Bank has no claim against the petitioner and the respondent-Bank has issued a certificate to that effect, in view of the same, nothing further survives for consideration in this writ petition.
