ORAL ORDER

Learned High Court Government Pleader accepts notice for respondent Nos.1 to 3. Notice to other respondents is not necessary for the following reasons.

2. Learned counsel for the petitioners submits that the earlier order passed by the Land Tribunal was set aside by this Court in LRP.No.3783/1990 dated 19.11.1997 with a direction to the Land Tribunal to reconsider the matter and dispose off the same within a period of six months from the date of the order. However, till date the Land Tribunal has not reconsidered the matter and has not passed any order and therefore, the prayer in the writ petition is to issue necessary directions to the Land Tribunal to take up the matter and dispose off the same within a time frame.



3. Accordingly, the writ petition stands ***disposed off***, with a direction to the third respondent Land Tribunal Gowribidanur Taluk to take up the matter in LRA/INM/N/28.16/70-71 dated 09.12.1981 and dispose off the same as expeditiously as possible and at any rate within a period of three months from the date of receipt of the copy of this order.
