2. Petitioner has sought for issuance of writ in the nature of mandamus to direct respondents to consider the representation dated 09.01.2026 produced at Annexure-K and to award compensation in accordance with the Compensation and Settlement Package for acquisition of lands for the Bangalore Suburban Railway Project.

3. Petitioner has stated in the representation that the amount of compensation fixed is below the guideline value and accordingly has sought for reconsideration of the amount fixed for the award.



4. Learned counsel appearing for the respondent – KIADB submits that the representation dated 09.01.2026 would be considered as per law.

5. In light of such stand of the 1st respondent, petition is ***disposed of*** directing the 1st respondent to consider and pass appropriate orders on the representation at Annexure-K dated 09.01.2026 within a period not later than 8 weeks from the date of receipt of certified copy of this order.
