Learned counsel for the appellant and learned
counsel for the respondents are present.

2. The appellant and the respondents have filed a
joint memo, the same reads as follows:

"The Appellant/s - Claimant/s has/have
agreed to receive and Respondent - RELIANCE
GENERAL INSURANCE CO. LTD., has agreed to pay
a lump-sum of Rs.7,00,000/-(Rupees Seven Lakh
Only) in addition to what has been awarded by the
Tribunal, in full and final settlement of the claim.



The Respondent - RELIANCE GENERAL INSURANCE CO. LTD., has agreed to deposit the said amount, before the Tribunal, within six weeks from the date of preparation of award failing which the said amount shall carry interest at 9% p.a. from the date of default, till the date of deposit. The parties are not entitled for any cost.

The parties to this appeal have set their hands to this settlement before the Lok Adalat in the presence of Conciliators on this 14.03.2026 at Bengaluru Bench”.
