ORAL ORDER

The petitioner is before this Court seeking for the following reliefs:-

"I. Issue a writ of Certiorari and quash the externment notice bearing No.M.A.G(GADIPARU)/CR/10/2025-26 Dated 19.12.2025 produced at Annexure-A;

II. Issue a writ of Certiorari and quash the rowdy/history sheet maintained against the petitioner by the Respondent No.2 produced at Annexure-C;

III. Grant such other reliefs as this Hon'ble Court deems fit in the interest of justice and equity".

2. Learned AGA submits that enquiry pursuant to impugned notice is under progress. At this stage a show cause notice cannot be quashed.



3. Learned counsel for the petitioner submits that this writ petition may be dismissed as not pressed with liberty to the petitioner to participate in the externment proceedings before the competent authority and challenge the order if the same is passed adverse to the interest of the petitioner.

4. Said submission is placed on record.

5. The petition is ***dismissed as not pressed*** with liberty as prayed for.
