The present writ petition is filed seeking following reliefs:

Wherefore, it is prayed that this Hon'ble Court be pleased to:-

a) Call for the records from the respondents which ultimately resulted in registering the Crime No.19/2023 by the Frazer Town Police Station-R3

b) Issue for an order, direction or writ in the nature of Mandamus directing an independent investigation by a DGP-CID Special units & Economic Offences-R-2 in respect of the Crime No.19/2023-Annexure-F & G

c) Issue for an order, direction or writ in the nature of Mandamus directing the first respondent to consider the representation dated 19.04.2023 sent through Email Id by the petitioner in respect of the Crime No.19/2023

d) Issue any other order, direction or writ/s as this Hon'ble Court may deem fit to grant, in the facts and circumstances of the case, including as to the cost of this Writ petition, in the interest of justice and equity.

2. Learned HCGP submits that the Co-ordinate Bench of this Court on 12.12.2023 has directed the petitioner to appear before the Investigating Officer on 13.12.2023 at 03.00 p.m. The petitioner has appeared, police have conducted the investigation and after that 'B' report has been filed on 09.12.2024.

3. In that view of the matter, this Court is passing the following:

- i. Accordingly, the writ petition is ***disposed of*** giving liberty to the petitioner to question the 'B' report.
- ii. All pending I.As., in the writ petition shall stand closed.
