The present appeal under Section 19(1) of the Family Courts Act, 1984 has been filed impugning the judgment and decree dated 28.03.2017 passed by the Court of Principal Senior Civil Judge and CJM, Chitradurga in M.C.No.74/2015 filed by the respondent-wife under Section 9 of the Hindu Marriage Act, 1955 seeking restitution of conjugal rights against the respondent-husband.

2. In view of the fact that a decree of divorce has been granted on the petition filed by the appellant-husband in M.C.No.13/2015, the present appeal has been rendered infructuous as the decree cannot be enforced once the parties
