CITY CIVIL AND SESSIONS JUDGE, BANGALORE CONFIRMING THE JUDGMENT DATED 26.02.2019 PASSED IN C.C.NO.14844/2017 ON THE FILE OF THE XII ADDL. AND 37TH ACMM, BANGALORE AND ACQUIT THE PETITIONER/ACCUSED.

THIS PETITION, COMING ON FOR REPORTING SETTLEMENT, THIS DAY, ORDER WAS MADE THEREIN AS UNDER:

ORAL ORDER

1. Learned counsel for the petitioner has filed a memo. Memo reads as under:

"The Accused humbly submits that,

1. An amount of Rs.1,10,000/- (Rupees One Lakh Ten Thousand only) has been deposited on 27.05.2019 vide D.D. No.903452 as a statutory deposit, same shall be withdrawn by the Complainant.

2. An amount of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) has been deposited on 24.08.2022 vide D.D. No.329781 drawn on Indian Bank and same shall be withdrawn by the Complainant.



3. An amount of Rs. 50,000/- (Rupees Fifty Thousand only) has been deposited on 21.09.2022 vide D.D. No.329820 and same shall be withdrawn by the Complainant.

4. The Appellant further submits that, the Appellant shall pay the remaining amount of Rs.1,90,000/- (Rupees One Lakh Ninety Thousand only) in 5 (five) instalments, which is as follows:

a. 15.04.2026- Rs.40,000/- (Rupees Fourty Thousand only)

b. 15.05.2026- Rs.40,000/- (Rupees Fourty Thousand only)

c. 15.06.2026- Rs.40,000/- (Rupees Fourty Thousand only)

d. 15.07.2026- Rs.40,000/- (Rupees Fourty Thousand only)

e. 16.08.2026- Rs.30,000/- (Rupees Thirty Thousand only)"

2. Counsel for the respondent has endorsed no objection on the memo.

3. Placing the memo on record, petition stand *disposed off*.

4. Amount in deposit, if any, is ordered to be withdrawn by the complainant under due identification.

5. It is made clear that if there is any default in the payment of compensation amount, then the petitioner
