ORAL ORDER

(PER: HON'BLE MR. VIBHU BAKHRU, CHIEF JUSTICE)

1. The complainants have filed the present complaint alleging willful disobedience of the order dated 12.02.2024 passed by the learned Single Judge of this Court in Writ Petition No.10/2024 (LA-RES). The said petition was disposed of by granting liberty to the petitioners (who are complainants in the present petition) to file a detailed representation to the accused showing the extent of land acquired and the necessary particulars to prove their ownership. The accused were directed to consider the same in accordance with law and pass appropriate orders.
2. A compliance affidavit has been filed affirming that the representations have been duly considered and a further sum of ₹48,58,829/- has also been disbursed.
3. In view of the above, the complaint is closed.



4. Needless to state that this order will not preclude any of the complainants to avail of remedies in the event they are dissatisfied with the actions taken by the accused.
