ORAL ORDER

(PER: HON'BLE MR. VIBHU BAKHRU, CHIEF JUSTICE)

1. The complainant has filed the present complaint alleging willful disobedience of the order dated 22.05.2025 passed by a Co-ordinate Bench of this Court in W.A.No.729/2025 (GM-RES).
2. In terms of the said order, the complainant was permitted to operate its Bank Account No.924020034960104 maintained with the Axis Bank Limited (accused). The same was subject to maintenance of minimum balance of ₹25,00,000/-.
3. The complainant alleges that the accused has placed a total freeze on its bank account.
4. The accused has now filed an affidavit affirming that the total freeze on the subject bank account has been lifted.



5. In view of the above, the complaint is closed and the complainant can operate its Bank account subject to maintaining minimum balance of ₹25,00,000/-.
