ORAL JUDGMENT

This contempt petition is filed alleging willful disobedience of the order of the learned Single Judge dated 07.09.2022, passed in W.P.No.34877/2015.

2. Learned Additional Government Advocate appearing for the respondent- State submits that the State Government has considered the request of the complainants as per the direction of the learned Single Judge and directed the Bengaluru Development Authority ('BDA' for short) to carryout necessary corrections in the revised master plan.

3. Learned counsel appearing for the BDA also filed a memo along with the Government Order dated 09.12.2025. In view of the Government order and the above said communication, we are of the opinion that there is compliance of the direction of the learned Single Judge and there is no willful disobedience.



Accordingly, the contempt proceedings are ***closed***.

Notice issued to the accused shall stand discharged.
