2. Respondent's Counsel did not turn up, even after service of notice.

3. Heard the argument of petitioner's Counsel.

4. This petition is filed by wife for transfer of M.C.No.7/2025 dated 06.01.2025 filed by husband for restitution of conjugal rights before Family Court, Davanagere. Petitioner filed M.C.No.312/2025 for divorce after filing of the case by her husband for restitution of conjugal rights at Shivamogga. Both the cases ought to be tried together by one Court to avoid conflict in the judgments. Therefore, this Court finds it reasonable to transfer the M.C.No.07/2025 from Family Court, Davanagere to Family Court Shivamogga to try along with M.C.No.312/2025 filed by wife for divorce.
