ORAL ORDER

This contempt petition is filed alleging willful disobedience of the order dated 12.07.2024 passed by the learned Single Judge in W.P.No.20924/2023 (S-RES).

2. The accused filed a compliance affidavit dated 22.09.2025. The said affidavit is sworn by the Director, Directorate of Pension, Small Savings and Asset-Liability Monitoring, Bengaluru. The said affidavit is accompanied by the documents at Annexures-R1 to R7 and an order dated 12.09.2025, wherein the case of the complainant has been considered, and subsequently found that the complainant is not a permanent municipal employee and has been ordered that his pension proposal is rejected.

3. In view of the specific order of the Authority, we find that there is compliance of the directions of the learned Single Judge and there is no willful disobedience.
