ORAL JUDGMENT

Learned counsel on both side present and stated that matter is settled before Lok-adalath and they filed a joint memo stating that they have settled it for lump sum of a global compensation of Rs.50,000/- and agreed to deposit the amount within 6 weeks from the date of award. Failing which, they also agreed to pay interest at the rate of 9% per annum from date of default till deposit.

2. Joint memo is recorded and accordingly this appeal is ***disposed of***. Petitioner is permitted to withdraw the entire amount along with interest accrued on it.
