ORAL ORDER

The petitioners have filed this petition seeking the following reliefs:

"a) Issue a Writ of appropriate nature declaring that Categorization of the Petitioner as in-eligible voter dated.02.12.2025, as per Annexure-C, is arbitrary

b) Issue a Writ of mandamus or any other appropriate writ or directions, directing the respondents to Permit the petitioners to participate, Contest & Vote in the elections to the 5th Respondent Co-operative society scheduled on 21.12.2025 for term 2025-2030 as per calendar of events dated.04.12.2025, vide Annexure-A, and

(b) Pass such other orders as may be appropriate in the facts and circumstances the case, in the ends of justice."



2. This Court, vide order dated 12.12.2025 permitted the petitioners to contest and vote in the forthcoming election of respondent no.5 - Society scheduled to be held on 21.12.2025. Pursuant to the interim order, petitioners have casted their votes in the election held on 21.12.2025 and the Returning Officer has declared the result of the election. It is contented that, in view of the same nothing survives for consideration.

3. Learned counsel for the impleading applicants contended that the writ petition filed by the petitioners is not maintainable. The petitioners have an alternative efficacious remedy. The petitioners without exhausting the alternative efficacious remedy have filed this petition. They submit that petition may be disposed of reserving a liberty to the aggrieved parties to raise a dispute under Section 70 of the Karnataka Co-operative Societies Act, 1959 before the appropriate authority.

4. Pursuant to the interim order, petitioners have casted their votes. In view of the same, nothing survives for



consideration in this writ petition. Accordingly, the writ petition stands ***disposed of*** as having rendered infructuous.

5. A liberty is reserved to the aggrieved parties to raise a dispute under Section 70 of the Act of 1959 before appropriate forum, if so advised.

Pending IA(s), if any, shall stand disposed of accordingly.
