ORAL ORDER

In this petition, petitioners seek the following reliefs:

*"a. Grant a writ of mandamus directing the XI
Additional Senior Civil Judge and JMFC at Mysuru to
dispose the O.S.No.1712/2007 within a reasonable time to
be fixed by this Hon'ble Court.*

*b. To grant such other relief/s as this Hon'ble Court
deems it fit to grant in the facts and circumstances of this
case including costs."*

2. After arguing the matter for sometime, learned counsel
for the petitioners seeks for a direction to the Trial Court to dispose
of the suit in O.S.No.1712/2007 as expeditiously as possible, within
a stipulated time frame.



3. The said submission is placed on record.

4. Accordingly, the Trial Court, before whom O.S.No.1712/2007 is pending is directed to dispose of the said suit, in accordance with law, as expeditiously as possible preferably within a period of one year from the date of receipt of a copy of this order.

5. The parties are directed to co-operate with the Trial Court for expeditious disposal of the suit.

6. Subject to the aforesaid directions, the petition stands ***disposed of.***
