ORAL ORDER

(PER: THE HON'BLE MR. JUSTICE HANCHATE SANJEEVKUMAR)

The petitioner/wife has filed this petition under Section 24 of the Civil Procedure Code, 1908, for seeking transfer of a case in M.C.No.30 of 2025, pending on the file of Principal Senior Civil Judge, Savadatti, to the Family Court, Gadag.

2. The respondent herein being husband of the petitioner has filed petition in M.C.No.30 of 2025, under Section 13(1) (ia) (ib) of the Hindu Marriage Act, 1955, for dissolution of marriage, before the Principal Senior Civil Judge, Savadatti.

3. The petitioner is residing at Kurtakoti village, Gadag District. She is a homemaker without having any source of income. The respondent/husband is a Government employee. Therefore, he is having income. The petitioner being a woman is facing difficulty to travel from Gadag to Savadatti to attend the Court case. Whereas, the



respondent/husband is able to travel from Savadatti to Gadag. Hence, the petition is liable to be allowed.

4. In the result, I proceed to pass the following:

ORDER

- i. The petition is ***allowed***.
- ii. The case in M.C.No.30 of 2025, pending on the file of Principal Senior Civil Judge, Savadatti, is transferred to the Family Court at Gadag, for disposal in accordance with law.
- iii. No order as to costs.
